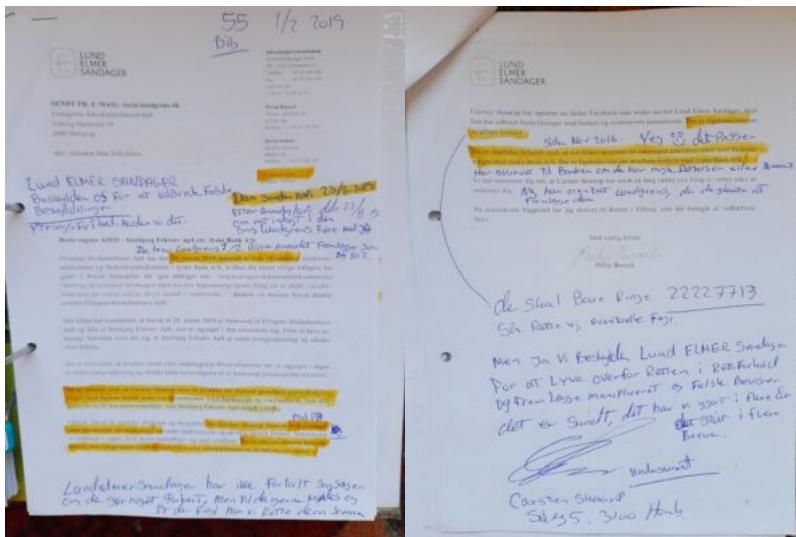

Not a single comment, apart from Jyske Bank Board member Philip Baruch and wrote a letter to the corrupt Lundgren's lawyers.

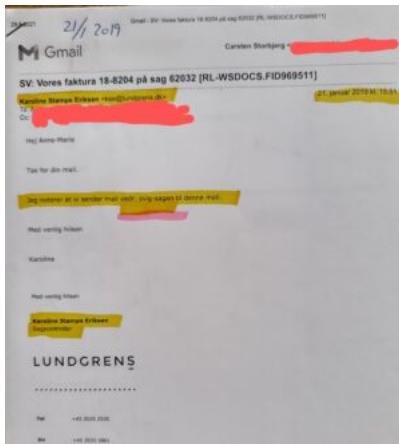

It is of course regrettable that the courts employ corrupt judges, such as Kurt Rasmussen, so when a Supreme Court judge has decided that the client of Lundgrens has no right to have the pleadings handed over, and that the client also does not understand that Lundgrens has received millions of Jyske bank.

The case is heard in the Viborg District Court, where the apparently corrupt Kurt Rasmussen is also employed, so we already know the judges' decision

I thought Jyske Bank's management should answer no one, this goes beyond Denmark, and the case or the story can damage trust in the Danish state, which I say and write covers obvious fraud by Jyske Bank.

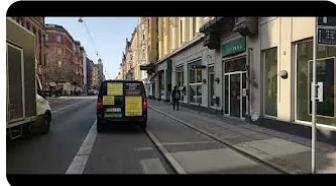

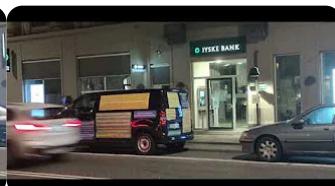

**You have my offer, I offer to hold a meeting where we can agree that we start a clean-up together.**

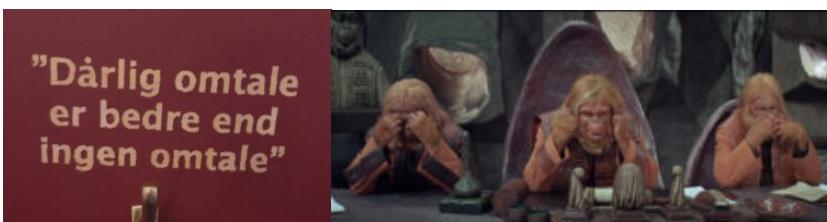
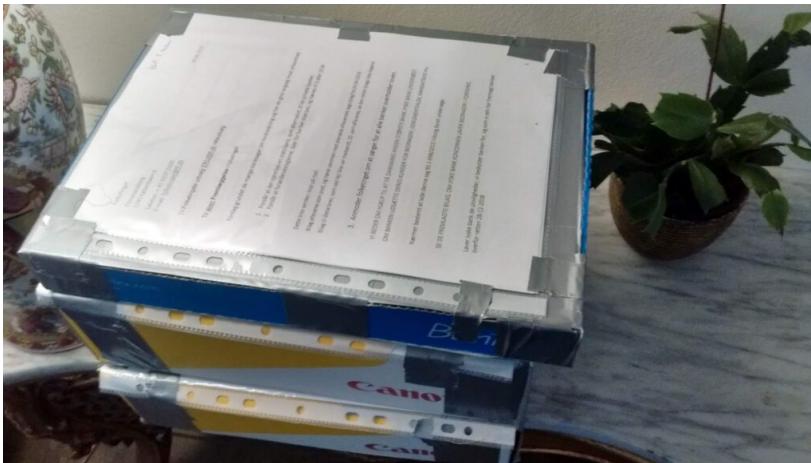
Your silence is not a solution to cover up the scandal.

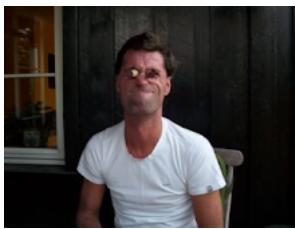
