I have previously notified the bank, that the company I no longer is the owner of the company that Jyske Bank has exposed to fraud and document forgery and what else I have written since 2016, and therefore there is no need to repeat everything again, by posting it here.

On example www.banknyt.dk you can find most of it, or links to what I have written about Jyke Bank, and the people who have and are behind the fraud i am written about.

The company formerly Storbjerg Erhverv ApS, as Jyske Bank knows it as, has made an agreement that a new director will be installed, and I therefore no longer want to know what the company is doing or not doing.

The company, as said in the management report, has written that it cannot survive after the contract with Jyske Bank A/S, and will therefore not be active as an operating company, but will only aim to advertise for the Jyske Bank car.
